- 10. Be able to engage fully in play and imaginative work.

Course Schedule:

The year of studio style components will cover:

Physical and Vocal warm ups/explorations (every class)

Acting technique /improvisation/analysis (every class)

Monologues (September- Fall Mid- Term)

Scene work (Mid- October to Fall Final and March- April))

Creative Writing/Collaborative Project(January)

Ensemble and solo creation projects (February- March)

Students will receive handouts with clear details, due dates, assessment criteria and instructions for each major assignment.

There are no formal examinations. Each student will receive a private mid-year and end of year assessment interview with the Instructor.

<u>Journal</u>

The journal is designed to provide a written record of class activities as well as the opportunity for self-reflection and clear articulation of discoveries within the work. The final journal paper will be a compilation of the term's discoveries and highlights presented in essay form. Please see Journal Handout for additional details.

Students will be expected to record daily class activities as well as their reflections on

At the end of term, the student will write a compilation paper based on important

discoveries, reflections and development throughout the term.

Although this assignment is worth only 10% of the term, the paper will have significant bearing on both the Participation and Growth and Development grades.

Assessment Expectations
