Description

Advanced creative work with an emphasis upon either chamber music composition or studio composition.

Outcomes

The course will focus upon the creative application of compositional craft. In addition to some introductory etudes, students will complete two compositions described below in which they demonstrate their ability to develop their musical materials in a coherent and dramatically convincing manner over an extended (multi-movement) duration. Students will also develop a vocabulary for constructive critique of the work of their colleagues.

The completed compositions will be for the following forces:

- 1. A duo for a selected orchestral instrument (percussion is excluded) and piano.
- 2. A trio for a homogenous ensemble of single line orchestral instruments (for example, three saxophones (SAT or ATBar), three clarinets (2 Bb and bass or 3 Bb), three trumpets, string trio, etc. A percussion trio must include only keyboard percussion instruments.

Activities

The course will begin with introductory work on a three-stage creative process: idea generation, idea exploration, longitudinal realization. Then, students will present work-in-progress for critique by their colleagues and the instructor. Discussions will also focus upon creative strategies and specific compositional issues relating to craft.

Students must satisfactorily (C- or better) complete every subsection of the above in order to pass the course as a whole. Students will submit the composition portfolio, on or before December 9, as computer-notated bound scores that meet the standards of the profession. Both compositions must be performed during the Student Composer Recital Hour during the last week of classes. Students are responsible for arranging rehearsal times and providing the performers with direction that leads to an acceptable performance. Professional commitment entails the following: providing professional-level parts in time for rehearsal for performance (multi-stand parts or parts with improper page-turns are un-professional); and **attendance at new-music concerts and other composer-oriented events**. Attendance at the majority of the Malcolm Forsyth: Perspectives and Legacy concerts and symposium (October 17 – 19) and attendance at all events surrounding the visit of Alexina Louie to campus (TBA – first week of November) are mandatory.
