Course description	Various topics such as applied music literature, piano, wind or string pedagogy, or vocal pedagogy, phonetics. Development of jazz improvisation skills through the analysis, performance and evaluation of jazz standards. Other topics will include digital patterns, licks, riffs, scale and chord theory/application, contrafacts and identification of chord progressions. Students will be given theoretical and musical tools to successfully improvise in the jazz idiom.

Course schedule	The course will be organized in six 2-week segments, starting on Mondays, each with a formative assessment on the first Friday and a summative assessment on the second Friday. In addition, students will submit two written solo transcriptions.
Assessment components	The dates of assessments are outlined below. Bi-Weekly Formative Improvisation Assessments I Type: playing improvisation assessment Value: six assessments at 5% each, totaling 30% Date: Every second Friday, on January 13, 27, February 10, March 3, 17 and 31. Details: Content will be based on the topics discussed, and music worked on, throughout the 2-week segment. Formative improvisation assessments will be based students in-class performance, demonstrating preparation of assigned materials.
	Bi-Weekly Summative Improvisation Assessments II Value: six assessments at 10% each, totaling 60% Date: Every second Friday, on January 20, February 3, 17, March 10, 24, April 12 Details: Content will be based on the topics discussed, and music worked on, throughout the 2-week segment. Summative improvisation assessments will be based on students in-class performance, demonstrating a greater understanding of, and proficiency with, assigned materials.
Assessment expectations	Solo Transcription Assignment Value: two assessments at 5% each, totaling 10% Date: February 17 and April 12 Details: Solo transcriptions should be a minimum of 2 choruses, or song form, in length. They must be notated by hand, or using music notation software. Transcriptions will be performed in class along with the original recording. Transcriptions must be memorized. Assessment will be based on the accuracy of rhythms, pitch, and stylistic nuance. Guidelines for Submitting Assignments: All assignments must be submitted in hard
	Missed or Late Assignments: Assignments submitted late will be assessed 2% penalty for every day late. The content of this course cannot be learned from a textbook – the skills can only be acquired through diligent practice and class participation.
