COURSE	This course uses an inquiry-based learning approach. The purpose of this course
DESCRIPTION	is to introduce graduate students and upper-level undergraduates to music

	will focus on the collection, management, interpretation and communication of
	information concerning music.

## COURSE The course will be held in a seminar format, allowing participants the **ACTIVITIES** opportunity to discuss and critically assess problems and issues concerning music scholarship and research techniques. Course content will focus on the acquisition of skills necessary to conduct **COURSE** CONTENT research and prepare reports and grant applications. During September, we will focus on basic concepts and techniques, notably finding sources, the structuring of bibliographies, the art and technique of footnotes and endnotes, etc. During October, each student will use this knowledge to prepare and present a grant application (either real or fictitious) with a clear, focused research objective. A successful assignment should be seen as a preliminary step towards the application for research grants offered by the institutions or funding agencies such as the Social Sciences and Humanities Research Council of Canada, the Canada Council for the Arts, etc. November and December will be devoted to the oral and written presentation of research reports. I. Researching reception. Students are required to prepare an annotated **ASSESSMENTS** (INCLUDING bibliography that will accompany an oral and written report on the English **APPROPRIATE** language reception of the one of the composers on the accompanying list. This **GRADING** assignment will be done in two stages: **SCHEME**) 1. Annotated bibliography: prepare a representative and balanced list of at least 20 sources (no more than 4 stand-alone websites) that provide information on the English language and particularly the North American reception of the composer you have chosen. Each source must be accompanied by a short paragraph explaining its pertinence to your project. The list should include primary source material (published texts, public comments made by the composer, interviews, etc.) and secondary sources (critiques and academic discussion of the composer and his or her music), as well as sources discussing the North American context within which this music circulated. The bibliography must be structured according to rules set out in The Chicago Manual of Style (15th or later edition). The bibliography is due 1 October (20%). 2. Oral and written report: prepare a short essay on the English language reception of your chosen composer (ca. 1500 words). Particular attention should be given to when and via which media his or her work began to circulate on this continent. If reception has been slight, try to explain why. The written essay will serve as the basis for the student's oral presentation. Oral presentations (10%) will take place on 26 November and 3 December; written reports (20%) are due on 3 December. II. Preparing grant applications. Building on the skills acquired with the bibliography assignment, students are required to prepare a grant application (either real of fictitious). This assignment will be presented in written form. The application should be based on the research/creative project that the student intends to pursue at the Master's or the PhD level. The written document will use the SSHRC application form as a template and will include the following: title, summary presentation of the research hypothesis/problematic or (in the case of composers and performers) creative objectives, theoretical criteria, methodology, time frame, expected results and bibliography. This assignment (20%) is due on Oct. 22 and will be accompanied by a short oral

presentation.
