	A significant part of your grade is based on participation.
	Participation means not only showing up for class, but also attending to the material at hand with effort and engagement.
	With regard to participation, classes are considered equivalent
	to assignments. Thus, more than 1, absences per term will have
	<u>an adverse effect on your final grade.</u> <u>If you miss more than one week of classes, your final grade will</u>
	begin to drop by as much as 10% per missed class.
	If you miss more than two weeks of classes, you have the
	potential to fail the course.
	If you show up late for or leave early from class, this will be
	counted as half an absence.

If for some reason you are feeling unwell during class time, a substitute form of participation may be arranged; however, you may not obtain this privilege more than once and you will receive half an absence.

For studio courses, if you opt out of full participation and choose to sit for a portion of the class, this will be counted as non-participation and will be marked as half an absence. Students are responsible for any and all material missed during an absence.

Guidelines for Zoom Sessions	Zoom is a video conferencing program that will allow us to meet at specific times for a "live" video conference, so that we can have the opportunity to meet each other virtually and discuss relevant course topics as a learning community.
	To help ensure Zoom sessions are private, do not share the Zoom link or password with others, or on any social media platforms. Zoom links and passwords are only intended for students registered in the course.
