Course description	<p><b>Practical experience in acting; improvisation and introductory work from texts; the development of communication skills and personal acting creativity.</b></p> <p>The focus of this course is to apply the techniques and theories described above through practical applications. These applications assist the student to embrace their own creativity, to cultivate it and grow in self-confidence and awareness of the opportunities to apply their creativity in a variety of areas. They will learn how to analyze text, develop a deeper connection to acting techniques that are sharpened through research and improvisation and to support working in teams towards a common goal.</p>
Course learning outcomes	<p>By the completion of this course, successful students will be able to:</p> <ol style="list-style-type: none"> <li>1. Collaborate responsibly in rehearsal and creation in partnership with others.</li> <li>2. Actively support the culture of respect and inclusion in the studio environment.</li> <li>3. Analyze and breakdown a script by applying the primary elements of acting technique, including playing objectives, tactics, listening and reacting.</li> <li>4. Be able to discern and identify the difference between demonstrating/indicating versus truthful, embodied acting.</li> <li>5. Choose appropriate monologues for an audition.</li> <li>6. Understand audition procedures and expected behavior in the process.</li> <li>7. Engage in effective character development.</li> </ol>

	8. Develop skills for presentational speaking.
Course schedule	<p>The semester will cover the following:</p> <ul style="list-style-type: none"> <li>- The Actor's Physical and Vocal Warm Up → on going</li> <li>- Actor's Legacy/ Solo Project → January - February</li> <li>- Scene work → February - March</li> <li>- Audition Monologues → March - April</li> <li>- Critical Analysis → February</li> </ul> <p>Detailed assignment descriptions, expectations and due dates will be posted on D2L</p>
Assessment components	<p><b><u>Assignment 1: Actor's Legacy</u></b>  Value: 30%  Due Date: Jan 26, Feb 2 and 9, 2021  Type: Solo presentation/written – 3 parts each worth 10%  Description: Self-generated character creation process and presentation of 2 minute monologue. Students will select an actor or theatre maker of notoriety and research this individual, then prepare three presentation techniques related to developing a character out of the person.  Part 1: Stream of Consciousness – Improvised stream in the present tense.  Part 2: Hot Seat – 10 minute question and answer period where the student must assume to know and have an opinion on a number of unpredictable questions poised from other classmates, from the point of view of the actor/ theatre maker they studied.  Part 3: Short monologue – Students will draft and present a 2 minute monologue, in the voice of your actor. Written monologues will be handed in.  Type: Presentation /written</p> <p><b><u>Assignment 2: Scene Study</u></b>  Value: 20%  Due Date: March 23, 2021  Description: Students will be assigned a scene to work on from the Instructor. The class will be working from the same play and we will witness the progression of the script through the work of the class. Detailed script analysis and breakdown as well as the presentation of the scene is the focus of this assignment. [further details will be posted on D2L]  Type: Presentation /Scene Analysis</p> <p><b><u>Assignment 3: Audition Monologue</u></b>  Value: 10 %  Due Date: April 13, 2021  Description: Students will find a monologue from a contemporary play [written after 2000], 1-2 minutes in length, to present as though it is an audition. Script breakdown and character analysis to be handed in. [further details to follow on D2L]  Type: Presentation / script analysis</p> <p><b><u>Assignment 4: Play Critique - TBD</u></b>  Value: 10%</p>

	<p>Due Date: February 11, 2021</p> <p>Description: Students will view a production [To be determined] and discuss the theatrical elements of the storytelling, covering acting, design and one other key component that stood out to them in the production. 1000 words.</p> <p><b><u>Assignment 5: Journal and Reflection Essay</u></b></p> <p>Value: 10%</p> <p>Due Date: April 13, 2020</p> <p>Description: Students are to keep a detailed journal of the in-class exercises and experiences, that will act as a reference document going forward. At the end of the semester, the student will write an essay reflecting on their progress through the semester, detailing the revelations and key moments of learning through the semester. 1000 words</p> <p><b>Participation / Growth and Development:</b></p> <p>Value: 20%</p> <p>Description: Students are expected to be in the classroom, prepared to begin at the start of class, whether in person or on Zoom</p> <p><b>Participation</b> includes attendance and constructive contribution to class discussions and the overall environment.</p> <p><b>Growth and Development</b> includes an evaluation of an individual student’s focus, concentration and effort in class – demonstrating concern and accountability toward the objectives and exercises presented to the group. This grade stems from an individual ‘s demonstrated ability and is gauged on the arc of improvement throughout the entire class, but also the singular investment in the progress of the ensemble.</p> <p><b>Participation</b> includes but is not limited to the power of observation when others are working and the ability and willingness to offer feedback and critical response. In addition to these assessed components the student’s attendance in class will also fall under this criterion – see below for further definition of this.</p> <p><i>Please note – cell phones, iPads and computers are not permitted in class, unless they are being used for group research as determined by the Instructor. If a cell phone is needed during a break the student must leave the class. Please come with a writing instrument and a journal in which to take notes.</i></p> <p><b><u>Appropriate Clothing</u></b></p> <p>Much of the work in this class is physical in nature therefore proper <i>neutral</i> movement cloths are required, no dresses or skirts. Please wear clothes that allow for flexibility in movement, being on the floor, dress in layers as the work will make you heat up and cool off intermittently. Make sure to have a pair of indoor shoes – outdoor shoes will not be permitted in class. NO HATS or GUM</p>
