Course description	From the calendar: "Immersive Theatre, Wearable Electronics for Costume Design, Design for Devised Theatre, Professional Practice and Career Preparation, Intimacy Coaching, Stage Combat Choreography, Site-Specific Theatre, Advanced Mask and Puppetry, Codes of Performance in Ancient Drama, and Directing, Design and Dramaturgy."
Course learning outcomes	By the completion of this course, successful students will be able to: <ol style="list-style-type: none"> 1. Define technology as it pertains to Drama historically and in the current context; 2. Illustrate the use of technology in Drama, discuss its role and explain why and how its contribution is valuable; 3. Construct a vision and plan for the use of technology as the driver of a new Dramatic work.
Course schedule	Each week the instructor will share materials relevant to that week's work. Students are asked to share questions / comments with the instructor who will provide answers relevant to the group (without identifying the source of the question) and individually where necessary. Regular check-ins via Zoom will be offered throughout the term.

Weight: 20% Due Date: January 29, 2021</p> <p>Assignment 2: Innovation Assessment Method: Group / individual assessment Description: students will study an innovative use of technology in the production of a Dramatic work and describe how technology was used to achieve artistic goals / practical goals. Weight: 20% Due Date: February 26, 2021</p> <p>Assignment 3: Drama Assessment Method: Group / individual assessment Description: students will explore a non-traditional use of technology where Drama is the key factor integrating the work. Weight: 20% Due Date: March 19, 2021</p> <p>Assignment 4: Creative Project Assessment Method: Portfolio review Description: students will create a proposal for a creative work that uses technology as the primary driver for production. Weight: 40% Due Date: April 9, 2021</p>

Zoom is a video conferencing program that will allow us to meet at specific times for a "live" video conference, so that we can have the opportunity to meet each other virtually and discuss relevant course topics as a learning community.

To help ensure Zoom sessions are private, do not share the Zoom link or password with others, or on any social media platforms. Zoom links and passwords are only intended for students registered in the course. Zoom recordings and materials presented in Zoom, including any teaching materials, must not be shared, distributed or published without the instructor's permission.
