Course Description	Advanced study in various topics related to theatre studies. In Winter 2024, this seminar will focus on playwriting by women from the 1990s to the present, identifying key concerns and theatrical/dramaturgical strategies that distinguish their work, as well as critical perspectives that illuminate their plays. The class will combine lectures, in-depth class discussion, student research presentations, and short video screenings.
Course Learning Outcomes	The course will familiarize students with a wide range of plays while fostering critical thinking, research, and oral and written communication skills.
