## <u>Assignment 6</u>: Curriculum and Course Design Incorporating Elements of Non-Western Music

Assessment Method: Written assignment

Description: Students will prepare a detailed curriculum/course design, based on their previously submitted alignment matrix, that incorporates elements of non-Western music learned in class, or from their own research. #### **Assignment 7: Student Lesson Presentations**

Type: Written Assignment

Description: Students will execute their submitted lesson plans in class, with classmates serving as simulated students. Detailed descriptions of assignments can

Weight: 20%

Dates: Students will be randomly assigned dates to present their lessons. Presentations will take place on March 29, 31, April 5, 7, 12 and 14, 2021

#### Assessment expectations

The content of this course cannot be learned from a textbook – the skills can only be acquired through diligent practice and class participation. Class participation is a necessary component of the course. Class discussion will occur at each class, and students will be assessed on their preparation and participation in each discussion. Absences are only accepted in cases of circumstances beyond the student's control, and must be supported by documentary evidence. In cases of absences due to circumstances known to the student in advance, advance notice of the absence must be given to the instructor. Students who miss class are responsible for getting any assigned homework and preparing it for the following class.
