Course description	<p>Various topics such as advanced band techniques and literature, choral techniques and literature, philosophy and foundation of music education or jazz for the classroom. May be repeated for credit.</p> <p>Music Technology for Educators examines how music-making technologies can be integrated into the Alberta music curriculum for all levels from K-12. Students will engage in several project-based learning experiences to develop their facility using multiple music technologies.</p>

Produce a piece of music individually using a digital audio workstation</li> <li>2. Produce a piece of music collaboratively with peers using a digital audio workstation</li> <li>3. Perform music in small groups using technologies/instruments introduced in the course (e.g., using smartphone apps, web-based applications, etc.)</li> <li>4. Design and prototype a new musical interface</li> <li>5. Plan and execute an independent project with guidance from the instructor</li> <li>6. Prepare and teach lessons on integrating music technology in the Alberta music curriculum for schools</li> </ol>
