Course description	Performance of selected early music, including research into its historical context and performance practice. Topics: Fall – Italian early baroque and the birth of opera. Winter – French baroque music. English baroque music of the same time periods will also be studied.
Course learning outcomes	<p>By the completion of this course, successful students will be able to:</p> <ol style="list-style-type: none"> 1. Explain the meaning of the term “historically-inspired performance” 2. Understand the importance of choosing good editions in early music 3. Discuss how music treatises from the past can impact its performance today 4. Approach the chosen styles with increased confidence going forward, and have a better understanding of appropriate ornamentation 5. Better use the text to shape the phrases in early music (in English and the other languages of the repertoire studied).
