Prerequisites	Admission to the Music major or minor.
Course description	<p>Development of skills in rhythm, intonation and sight-singing. Performance of two-part contrapuntal exercises with diatonic modulation. This course meets for three hours per week during the Fall and Winter terms.</p> <p>This course focuses on aural skills, the training of the ear. Students will strengthen their aural skills through sight-singing and notating melodies, chord progressions and rhythms by ear. Students will also develop basic keyboard skills.</p>

Course learning outcomes	<p>By the completion of this course, successful students will be able to:</p> <ol style="list-style-type: none"> 1. Sing rhythms, melodies and chord progressions that are diatonic with some chromatic elements (this will be sight-singing with the use of solfège). 2. Notate rhythms, melodies, and chord progressions by ear (mostly diatonic, with some chromatic materials). 3. Play basic chord progressions on keyboard instruments.
Course schedule	<p>Details given in class and on D2L. There will be weekly dictations and weekly singing assignments.</p>
Assessment components	<p>Class Preparation / Participation Weight: 10% of final grade Due Date: ongoing Details: Students must be in class and participate!</p> <p>Graded Assignments / In-Class Quizzes Weight: 40% of final grade, with all assignments and quizzes being of equal weight (late assignments will not be accepted) Due Date: various; TBA in class and on D2L Details: dictation, keyboard, rhythm and singing assignments</p> <p>Singing and Dictation Exams Weight: 50% of final grade Date: TBA in class and on D2L Details: dictation and singing/keyboard exams; 2 exams this semester and each exam has both a written and practical component. These exams have a weight of 25 % each with the written and practical component of each exam breaking down into 12.5 % each.</p> <p>Your grade from MUSI 225A will be averaged with the grade from MUSI 225B to arrive at a final grade for the course (each half is worth 50% of the total grade).</p> <p>There will be no registrar-scheduled final exam for this course.</p>
