#### **Description**

Advanced creative work with an emphasis upon either chamber music composition or studio composition.

#### **Outcomes**

The course will focus upon the creative application of compositional craft. In addition to some introductory etudes, students will complete two compositions described below in which they demonstrate their ability to develop their musical materials in a coherent and dramatically convincing manner over an extended duration. Students will also develop a vocabulary for constructive critique of the work of their colleagues.

The completed compositions will be for the following forces:

1. Large scale work: piano trio (violin, violoncello, piano) maximum duration of five minutes.
2. Short work: A trio for a homogenous ensemble of single line orchestral instruments or three voices without use of a text (for example, SSA vocalize, three saxophones (SAT or ATBar), three clarinets (2 Bb and bass or 3 Bb), three trumpets, string trio, etc. A percussion trio must include only keyboard percussion instruments. The combination may not include the students' instrument. (minimum 3 minutes, maximum five minutes)

The piano trio (score and parts) will be completed by November 18 in time for a workshop on December 6 that will be a reading session with the members of the Lands

End Ensemble. The Ensemble will then select some of the pieces from this session to include in a public performance, tentatively scheduled for the Alchemy series in April.

- November 8 (on or before 16:00): Completed score submitted to D2L Dropbox
- November 15: Completed score returned to students with instructor suggestions for corrections and/or slight revisions
- November 18 (on or before 16:00): Corrected score submitted to D2L Drop box

**Note:** No piece that is not notated to the standards of the profession will be submitted to the LE ensemble.

The short work (score) will be submitted on December 9 (on or before 16:00), via the D2L Dropbox.

### Activities

The course will begin with introductory work on a three-stage creative process: idea generation, idea exploration, longitudinal realization. The focus of this work will be on harmonic and polyphonic procedures. Students will present work-in-progress for critique by their colleagues and the instructor. Discussions will focus upon creative strategies and specific compositional issues relating to craft. Students will develop a vocabulary for approaching the critical assessment of creative work.

### **Learning Technologies and Requirements**
