Since Max is a paid software, either a purchase of the program (250 USD) or a three-month subscription (3 x 9.99 USD) will be required to save projects after its 30-day trial period is over. Students can access the program for free in the Integrated Arts Media Lab (wpsites.ucalgary.ca/iaml/).</p>

Course description	<p>Use of computers in music composition, performance, education and interdisciplinary media.</p> <p>An introduction to concepts and techniques of computer music with an emphasis on interactive applications and programming. Through the completion of a series of applied creative projects, students will acquire a basic understanding of various creative and technical approaches to the use of computers in sound and music.</p>
