Course description	<p>This course will examine the development of the idea of nationalism in music from the late eighteenth century to the early twentieth century, the era of musical Romanticism. Using selected works by Schubert, Weber, Mendelssohn, Brahms, Mahler, Chopin, Liszt, Glinka, Balakirev, Borodin, Mussorgsky, Tchaikovsky, Rimsky-Korsakov, Grieg, Sibelius, Smetana, Dvorak, Albeniz, Elgar, and Vaughan Williams, the course will explore the ways in which composers strived to represent “national” style in musical terms.</p> <p>The course will consist of a series of three study "modules" (or units) involving readings, listening assignments, and in-class discussion questions of a historical or analytical nature. The course will be divided into three teaching units, each of which concludes with a test involving listening, historical questions, and analysis.</p>
Course learning outcomes	<p>By the completion of this course, successful students will:</p> <ol style="list-style-type: none"> <li>1. Have a good overview knowledge of nationalism in music from 1800 to 1914.</li> <li>2. Have a working knowledge of the major modern writings concerning musical nationalism during the period under study.</li> <li>3. Have an introduction to the history and culture of Europe during the period under study from the perspective of national culture.</li> <li>4. Be able to analyze the works of music from the perspective of musical nationalism during of period under study.</li> </ol>
Course schedule	Aside from lectures, there will be four evaluation components: two tests and the final examination, plus a term paper.
