Course description	An introductory course to vocal pedagogy focused on the basic anatomy, physiology, and coordination of the vocal instrument, as well as teaching concepts and strategies appropriate to both solo and choral applications.

Describe the basic anatomy and physiology involved in voice production.</li> <li>2. Discuss resonance and acoustics as they pertain to voice production.</li> <li>3. Be able to analyze and suggest solutions for basic vocal problems/issues.</li> <li>4. Discuss various aspects of healthy use of the voice.</li> </ol>
