Course description	SCPA 499 provides students with an introductory-level understanding of interdisciplinary <i>principles, strategies and tools</i> for exchange and collaboration in interarts and interdisciplinary contexts. In addition to introductory conceptual knowledge and exposure to a wide range of case study examples, students will be offered practical approaches to interdisciplinary creation and interpretation, as well as opportunities to explore these approaches individually and with peers from all three divisions of the SCPA. Students will be expected to work on a collaborative group project outside of class hours for successful completion of the course.

Course learning outcomes	<p>By the completion of this course, successful students will be able to:</p> <ol style="list-style-type: none"> <li>1) Explore theories, concepts, and approaches possible through interdisciplinary collaboration.</li> <li>2) Discover how current understandings of interdisciplinarity relate and apply to performing arts.</li> <li>3) Investigate practical strategies and tools for creation and interpretation in interdisciplinary performance contexts.</li> <li>4) Develop effective skills for creative collaboration across disciplinary boundaries.</li> <li>5) Articulate interdisciplinary performance practice through writing and spoken presentation.</li> </ol>
Course schedule	A detailed course schedule will be provided in class and maintained on D2L.

### Assessment components

- **1) Class Participation: 20% of overall grade**

All students are expected to attend all classes, arrive on time and fully prepared (having completed all assigned readings and/or viewings), and participate actively in all sections of each class.

Criteria for assessment will include *attendance, demonstrated preparation, active participation, collaboration, creativity and respectful exchange*. Attendance will be tracked throughout the semester and will serve as one measure of class participation.

**Note: given the importance of this aspect of the course, students for whom active in-class participation is difficult or impossible should identify themselves to the instructors within the first 2 weeks of classes.**

- ***In the event of a COVID 19 diagnosis, symptoms, and/or required isolation, arrangements for remote access to missed material will be made by instructors, if given advance notice by student.***

- **2) Written Reflections on 3\* Performance Works: 15% of overall grade (5% each)**

All students are required to view **three** performances during the semester and write a brief (250 word) reflection on each. In the interest of facilitating a continued return to LIVE art, students are asked to see three live performances. Students must see one performance each that focuses primarily on the specific disciplines of Drama, Dance, and Music. Performance options will be suggested by the instructors and posted on D2L, but students are also encouraged to select their own works. Performances that are available for free on University campus are valid. Live events can be in-person or digital.

**Two** of the reflections will be on disciplines outside your practice. For these reflections, analysis of the performance should emphasize key observations about the discipline and how it connects to discipline specific concepts discussed in class.

**One** of the three reflections will pertain to your particular discipline. For this reflection, discuss insights gained about your discipline through the introduction to your discipline offered in the class. Further, if applicable, describe ways in which the work has been enhanced through interdisciplinary elements and engagement.

\*Students may also write **one additional reflection for extra credit** at the same assignment value per reflection.

Live performance reflections must be accompanied by the related **ticket stub** (unless other arrangements are made with the instructor).

Please note that in the case of a live performance event, it is the responsibility of each student to plan, book, and (where applicable) pay for their tickets and for their transportation to and from each performance venue. **FINAL DEADLINE for ONE reflection: February 26 / 2024; Second and Third reflection: April 08 / 2024 - early submission is encouraged**

- **3) Written Individual Creative Exploration: 25% of overall grade**

Each student will individually explore the steps of a creative process using interdisciplinary approaches to further enrich their work in their own discipline.

For this assignment, students will look to a discipline other than their own program of study and choose an element (or elements) from that discipline to bring into their work in their primary discipline. Students will be asked to detail their performance plan (the how) and dramaturgical reasoning (the why) of their proposed work. (1000 - 1500 words plus supporting materials and Works Cited as required.) **Assignment due date: February 19 / 2024**

- **4) Collaborative Creation and Presentation: 40% of overall grade**

All students will participate in a collaborative project/presentation with class members from all three SCPA divisions, demonstrating the application of interdisciplinary collaboration principles and strategies explored in the course. The group presentation will involve a short performed excerpt of the larger creative concept and a presentation discussing the group's creative process. Students will also submit a group-authored report detailing the collaborative working process as well as an individually-authored report, detailing individual contributions, key take-aways, and process documentation. **Collaborative presentations: March 18 & 25 / 2024 Final Deadline group papers and individual reflections: March 27 - submission on day of presentation is encouraged**

**Note:** Detailed descriptions of evaluation items #2, #3, and #4, will be discussed in class and posted to D2L.
