Course description	In this course, students from Music, Drama and Dance will be introduced to a generative mode of seeing and doing that is simultaneously spatial, temporal and sensory. Students will be encouraged to actively experiment with how space, time and embodiment figure in their creative practice. Within this interdisciplinary framework, a collaborative, process-led approach will ground embodied, studio-based experimentation. Methods and ideas distilled from contemporary choreographic practice allow students the opportunity to develop and challenge their own making processes and current research in collaboration with their cohort. Each student will create and present a series of performance projects as well as participate as a performer in the work of others, contribute to lively feedback sessions, and develop skills in participatory and holistic critique.

Course learning outcomes	<p>By the completion of this course, successful students will be able to:</p> <ol style="list-style-type: none"> 1. Expand and experiment with how time, movement and embodiment figure in both creation and performance across disciplinary modalities; 2. Identify the formal and conceptual underpinnings of one’s own approach to interdisciplinary performance creation and develop associated language to share and collaborate with peers; 3. Develop an enhanced awareness of the processes of preparation and presentation of live performance offerings; 4. Generate and share productive feedback on the work of peers as well as respond to and integrate the feedback of others in relation to one’s own work.
Course schedule	<p>During this five-day intensive in-studio course, students will prepare and present a series of 4-6 short performance-based assignments, working individually, in duos, and larger groups; participate in group discussions and feedback sessions; learn a series of strategies and games including movement generating practices, walking scores, decision-making, intention and awareness protocols, writing and reading as performance, dramaturgical toolkit. Further details on specific in-studio assignments will be listed on the D2L site the week of the course.</p>
Assessment components	<p>1) Class Participation: 20% of overall grade All students are expected to attend all classes, arrive on time and fully prepared, and participate actively in all sections of each class.</p> <p><i>Criteria for assessment will include attendance, demonstrated preparation, active participation, collaboration, creativity and respectful exchange.</i></p> <p>2) Interdisciplinary Performance Creation: 40% of overall grade Each student will create a series of short performance projects (in solo, duo and group formats). Students will prepare and direct each project, demonstrating their commitment to experimenting with interdisciplinary approaches, collaborative process and embodied research. Students will also develop and practice interacting with others in a leadership role.</p> <p>3) Collaborative Presentation and Feedback: 40% of overall grade Each student will share their performance creation work with the rest of the group, participate in feedback sessions – both receiving and integrating peer’s feedback on their own work as well as articulating meaningful and productive feedback on the work of others.</p>
